Introductions

#### Eco Fair report — Rennie

- Como Park District Council sponsored it on Sat., August 13; it is the brainchild of Jennifer Victor-Larsen (District 10 board member and founder of Donate Good Stuff)
- Rennie attended for 4 hours, Lizzy could not come
- Description: 12 vendors, 4k race took place before, only food items were apples and bananas
- Rennie sponsored table about recycling, had a game (what goes to trash, compost, recycling)
- Good opportunity to talk to people about a range of issues, from rent stabilization to composting, make connections and share information
- Next year, as a committee, what would we like to see at the table? Get more resources there. We should brainstorm what we want to participate
- Mike: Eco Fair at the State Fair might offer some ideas of things to promote
- Patricia has organized a similar event, the Frogtown Carnival, on Sat., August 20; had more people, thanks to food and promotion, many more children

- Michael: MWMO has large granting programs, St. Paul has a very small sliver
- Received grants before for buckthorn removal (Karlyn and Stephen Massey wrote them)
- Kasota Ponds have fair amount of buckthorn still; excess salinity, from runoff from the roads and parking lots, very difficult to get rid of, would have to dilute it
- Runoff in the ponds, some connection between the ponds, pipes, eventually goes
  to stormwater system, Bridal Veil Falls study has been done, large document,
  interconnection of wetlands, these are remnants of the wetlands, north pond
  used to be an ash dump, also hospital waste, heavy metals, glass shards, and at
  the south end of creosote and petroleum products
- Goal is to clean it up and make it more public, want to support wildlife, three types of turtles, lots of invertebrates
- MWMO did long-term study, summarized 2018 or 2019, 5-year study, conclusion: need to find rate of inflow of water, there is a spring in the east pond, would like to increase it or the outflow rate; Aaron Hinz (grad student on EC) suggested setting up a solar powered desalination station, use solar-powered pump; good idea; have to be in middle of the pond; Aaron has connections to someone who has created that sort of system before
- Corey: better signage, discourage dumping
- Michael: there is some signage, had one made, complicated as the property has different owners: city, Napa Auto Parts, etc.
- Val: use buckthorn blaster?
- Patricia: Great River Association is working on buckthorn removal at Frogtown Green Farm, no herbicides can be used, cutting and bagging and goating (year 2)
- Mike: MWWO grant option are \$30-50K for community, planning, action

- Can we hire anyone? Conservation core?
- Kerry: Could we seek out help from Friends of the Mississippi River? They
  recently published a two-year study about different processes for buckthorn
  removal, see here:

# Rain Garden Maintenance Grant update — Kerry and Val

- Kerry has been in touch with Matt Wildenauer; he agrees that the Raymond/Ellis site cannot be improved as all the dogwood died; perhaps it is too dry? We need to get another grant to see that it is redone.
- Michael: Bayless does not drain well, but the city worked on it
- Kerry: Matt will be providing a summary of the maintenance he can do/oversee for us at the Raymond/Bayless site; he intended to get it to us by this meeting but he is up north and without computer access until later this week.

- EC can do maintenance via trash clean up at Ellis site, but focus will be on Bayless site this fall; have until Dec. 1 to submit request for reimbursement up to \$2K from CRWD
- Michael: Need a summary/assessment before next CRWD grant cycle, convince them to fix Ellis pond, delay maintenance
- Patricia: Check to see if Rachel Funke from CRWD will look at the Ellis rain garden for her input

#### 100 Trees Initiative — Manu

- Talked to Ben Shadlow, associated with Creative Enterprise Zone (CEZ), he did a
  fundraiser to raise \$ for a watering trailer, Mike Gunderson donated \$1K to get a trailer,
  not yet fully funded; general concern about the high number of trees that are dying
- Kerry: The CEZ is organizing the watering of trees every Wednesday, 5:30-7 p.m.;
   received an email from Angela Casselton about watering; not sure where they meet, what the process is, etc.
- Val: The north Territorial dead trees have been removed, she corresponded with Ben
- Manu knows people who would be willing to help water, as would other EC committee members; Kerry will email Angela to make sure our EC committee members are on the emails about watering

## Ice Cream Social planning, Sept. 17, 2 to 5 pm — Kerry, Bill, others

- Kerry read the info from the overview email that Jessica sent to SAPCC board members:
  - Interactive Art by Springboard for the Arts
  - Music by the Hampden Park Rounders

  - Storytime from the SAP Library

- Michael: Flyering is essential; would be good if people in apartments passed out flyers or spread the info, post at entrances of buildings
  - o Manu best approach is to use the neighborhood app and the list serv; she thinks it is difficult to reach people in her apartment building with flyers; talking to residents in elevators works better!
